She also mentioned that WTPOD were under the impression that residents would automatically transfer to the new program. Ms. Howard asked when the program would go into

effect.

c. Norrel Hemphill, Legal and Policy Manager with WTPOD, thanked Mr. Phillips for the information that was received. She asked when do the process go into effect and what is the process. She also said that how to apply to the program and who would be eligible were never communicated. Ms. Hemphill asked the BOWC to consider supporting House BIII #4555, which is a true water affordability program.
