1. CALL TO ORDER

Chairman Einheuser called the public hearing to order at 2:00 p.m.

3. APPROVAL OF AGENDA

Chairman Einheuser requested approval of the agenda.

A motion was made by Commissioner Mary Blackmon, seconded by Commissioner John Henry Davis that the agenda be approved. The motion carried by a unanimous vote.

5. PUBLIC HEARING COMMENTS (3 minutes per speaker)

- a. Commissioner Forte asked what was the interest rate on the loan program. Monica Daniels, Finance Asset Manager replied 2.5%.
- b. Commissioner Kinloch stated that at a Virginia Park Community meeting, it was asked why were there so many water main breaks, and if they were due to the aged infrastructure. Director Brown replied, breaks occur in the cold and hot temperature. The real issue is the decades of deferred maintenance.
- c. Michelle Broughton of the Councilman's Office asked if there would be any cost to the homeowners for the Water main replacement. Director Brown replied, there is no direct cost to homeowners. The bonds will be paid out of rate dollars. The \$50 million we receive from GLWA, a portion of that funding comes from the suburban partners to help service the debt.
- d. Beulah Walker stated that Hydrate Detroit would continue to advocate for customers who need service line replaced. She also said that she heard that some areas would be excluded from receiving the lead service line replacement. Director Brown replied that there will be additional contracts for the Districts to receive relief for service lines, water mains, and sewer main replacements.
- e. Phillip Shane asked if both Project Plans A and B are being replaced. He also asked how is the Brightmoor area insured that they are included in the lead service line replacement. Director Brown replied, the project includes both A and B plans. The intent is to put a contractor in every District of the City.
- f. Valerie Brannas asked if the plan A and B for water main replacement or service line replacement. Director Brown replied that when the water main is replaced if will also replace the lead service line, if needed.
- g. Jermaine Paynes stated that he resides in the 15119 District area. He asked what part of the Greenfield District will be covered. Director Brown replied that he was not sure but someone would follow up to his inquiry.
