1. CALL TO ORDER

Chairperson Einheuser called the meeting to order at 2:00 p.m.

3. APPROVAL OF AGENDA

Chairperson Einheuser requested approval of the agenda.

- a. Cecily McClellan asked if the Department could provide the shutoffs listing by zip code. She also stated that according to the Lifeline dashboard data why was there a decrease of two thousand in the number of residents that were receiving benefits from 75,000 in May to 73,000 in July. Ms. McClellan also asked how many of the 1400 residents who receive water conservation services were referred to a plumber.
- b. DeMeeko Williams, Chief Executive Director of Hydrate Detroit, reported that they

are sponsoring a Share Water Drive on Saturday, July 20, 2024 in collaboration with Wayne Metro. He thanked DWSD's public affairs team and the other activists for lending their support to the cause. He is also happy for the new EasyPay payment plan.

- c. Sonya Brown came to thank DWSD and Beulah Walker for assisting with the community street flooding. She hopes the collaboration this weekend will help resolve these issues.
- d. Norrel Hemphill, Attorney with Environmental Law submitted, written communication dated July 26, 2024 for the record.
- e. Gabriel Marshall and RodneyThomas came because the property they purchased at 5555 Woodhall Street through the Wayne County Auction had been disconnected from the city's assets. They also mentioned that several of their properties experience basement flooding every rainfall.

Beulah Walker with Hydrate Detroit came to thank the Department, the Board of Water Commissioners, and Director Brown for always assisting Hydrate Detroit.
