8. NEW BUSINESS

16-0193

The Board of Water Commissioners for the City of Detroit Water and Sewerage Department approves the proposed budget amendments of the FY 2016-17 budget to increase funding for the water system's Water Residential Assistance Program (WRAP) budget by \$810,000.00 and the sewage disposal system's Water Residential Assistance Program (WRAP) budget by \$1,215,000.00 for the City of Detroit Water and Sewerage Department, and also authorizes the Director to take such other action as may be necessary to accomplish the intent of this vote.

Mia Kupp and Jerone Drain with Wayne Metropolitan Community Action Agency came before the Board to provide an update on the Water Residential Assistance Program (WRAP). Ms. Kupp reported that since the launch of the program in March 2016 Wayne Metro has over 11,000 appointments scheduled, 5,300 enrolled, 85 percent Detroit residents. To date \$5 million has been committed to WRAP funding. This exceeds the allocations from the GLWA, which was \$1.3 million for the City of Detroit. Thanks to Director Brown and Wayne Metro for an additional \$1 million and also funding from the Michigan Health Endowment Fund to raise another \$2.2 million to support the WRAP fund. There is a 90 percent retention rate. Of the 4,500, 10 percent has been unsuccessful. There will be an opportunity for Detroiters and all WRAP participants to re-enroll in year two if they have arrears. We are also considering in March during enrollment, to extend the assistance of the \$25 monthly stipend along with the \$750 payment for arrears. Due to the funding and volume remaining, we've had to severely reduce the number of residents we can enroll on a daily basis. We were setting appointments for about 80 individuals per day and had to cut to about 20 per day. Worked with Mr. Brown and team to create a waiting list of about 350. If an individual is on the waiting list, they will not be shut off until we have made contact with them. Over 900 Detroiters are above average usage and after repairs almost 500 residents had decreased their bills and were taught ways to conserve water. Detroiters are also attending two-session smart class at one of the nine locations throughout Wayne County. Smart classes provide energy, water and financial coaching.

A motion was made by Commissioner Linda Forte, seconded by Commissioner Lane Coleman that this Contract Amendment be approved. The motion carried by an unanimous vote.

16-0194 The Board of Water Commissioners for the City of Detroit, Water and Sewerage

Department authorizes the Director to grant an increase of \$200,000.00 in the contract price for Contract No. CS-1820 "Drainage Charge Program Consulting Services" with Galardi Rothstein Group, LLC (Consultant), and also authorizes the Director to take such other action as may be necessary to accomplish the intent of this vote.
