Demolitions:	
● Demolition water line disconnection	\$ 700.00
● Hydrant water use for residential demolition	\$ 510.00
● Hydrant water use for commercial demolition	\$ 1,920.00
Illegal Dig-Ups and Sewer Taps:	
● 1st Offense	\$ 1,000.00
Illegal dig-ups non-refundable and the contractor's name will be placed on a list	
● 2nd Offense	\$ 3,000.00
Violators will be suspended from DWSD for one-year period, and pay a reinstatement fee before their name can be removed from list	
● 3rd Offense	\$ 5,000.00
Be placed on a non-compliance list and must pay all above fees plus place a retainer to be held against any further violations for five years	
Sewer Penalty (from previous ending balance)	5%
