The Detroit Water and Sewerage Department (DWSD) conducted a site visit to your parcel at 4106 28th Street on January 31, 2020. At the site visit, DWSD Engineers reviewed the site impervious area and the opportunity for Drainage Charge Credits (green credits) at your parcel.

The findings from the site visit confirmed the previously determined impervious area of 0.18 acres. The green credit calculated for your parcel does not exceed the 25% credit that is automatically applied to all residential customers. Customers receive the automatic residential credit or the calculated green credit, whichever is higher. Therefore, you will continue to receive the 25% automatic residential credit.

PROCEDURES FOR FILING AN APPEAL TO THE DISPUTE REVIEW PANEL

In order to properly appeal a determination issued by the Detroit Water and Sewerage Department to the Dispute Review Panel, you must timely submit the proper documentation. You are welcome to consult an attorney for assistance.

To file an appeal of the Department's determination, you must submit a written letter requesting an appeal of DWSD's determination and include all of the following:

1. A copy of the decision letter that you are appealing.
2. A copy of any and all documentation that support your appeal.
3. A concise, yet detailed, statement of the basis for your appeal.

The above documentation must be received by DWSD within thirty (30) days of the date of the determination. Appeal requests can be mailed to the Office of General Counsel, ATTN: Dispute Review Panel, 735 Randolph St., 9th Fl., Detroit, Michigan 48226. Appeal requests can also be emailed to: branchni@detroitmi.gov.

Within 15 days of receipt of your appeal, you will receive documentation from DWSD acknowledging the timely receipt of your appeal and providing you with the date, time and location for your hearing.

Decisions by the Dispute Review Panel are final and are not subject to appeal, except as provided by law.
