3. All records pertaining to any electrical power failure at Connor Creek Pumping Station which effected the operation of any pump(s) from January 1, 2011 through the present.
4. All records pertaining to any testing of the Connor Creek pumps from January 1, 2011 through the present.
5. All records pertaining to Connor Creek Pumping Station equipment operation and/or malfunction beginning January 25, 2021 and continuing through the present.
6. All contracts and/or engagement letters with any entity which has been retained to conduct the after-event analysis pertaining to the events of June 25 and/or June 26, 2021 with regard to the Connor Creek Pumping Station.
