1. CALL TO ORDER

Chairperson Einheuser called the meeting to order at 2:00 p.m.

3. APPROVAL OF AGENDA

Chairperson Einheuser requested approval of the agenda.

A motion was made by Vice Chairperson Mary Blackmon, seconded by Commissioner Lane Coleman that the agenda be approved. The motion carried by a unanimous vote.

Commissioner Davis joined at 2:05 p.m.

4. APPROVAL OF MINUTES

Chairperson Einheuser requested approval of the minutes of February 15, 2023.

A motion was made by Commissioner Jane Garcia, seconded by Vice Chairperson Mary Blackmon that the minutes be approved. The motion carried by a unanimous vote.

5. PUBLIC COMMENTS (3 minutes per speaker)

- a. Norrel Hemphill with the Great Lakes Environmental Law Group wanted to acknowledge the wins with the Detroit Lifeline Plan. She was thankful for the name change from affordability versus assistance. She was appreciative of the opportunity for community feedback; community engagement; the forum to work with the Ombudsman and Wayne Metro to get customers enrolled and issues resolved, plus the increase in ccf's usage. She suggested that the Department provide a dashboard with the date and proper language so residents can see the enrollment as it is updated, and allow Wayne Metro access to accounts to make changes and give customers a moratorium as soon as they apply. She also said that there is a need to provide a process for hardships.
- b. Bob Rhoades came before the Board about the lead service line replacement program and the inconsistency with the layout of the program.
- c. Beulah Walker with Hydrate Detroit came to thank the Water Commission and Wayne Metro for its transparency throughout the implementation of the Lifeline Program. She also apologized for relaying some misconstrued information.
- d. Cecily McClellan with We the People of Detroit was thankful for the Lifeline Program. She believes that an additional increase in the ccf's would help with the hardship customers.
- e. Gwendolyn Howard asked would this program phase out? If so, when would the phase out start? Would the Lifeline Program continue with the funding coming from the State? She also asked if there was enough funding to continue enrollment and all the existing Lifeline benefits, arrears, income-based, etc.
- f. Louella Pizzuti came to inquire about a number of lots that are on hold by DWSD in the Brightmoor area. Director Brown replied that those parcels are controlled by the Land Bank and if she was interested in any specific parcels she could attend their public meeting or write to the Land Bank to address her concerns.
- g. Demeeko Williams, Chief Director of Hydrate Detroit stated he was pleased and happy to hear the good news about the Lifeline Plan. He continues to rally for a water amnesty.
- h. Tiana Starks said she was thankful for the Lifeline plan. She appreciated the website weekly data updates. She looks forward to a revised policy that would address the gallons per person usage.
