a. Cindy Darrah asked if the public could join the Board on its tour. She also mentioned that Council's Budget Hearing was scheduled for March 23 and suggested that the Board hold an additional meeting prior to March 23 to include any additional matters to the budget.

b. Demeeko Williams commended DWSD on the development of the Lifeline Plan. He was thankful that the gallons per person household size allotment was increased to a more reasonable amount.

Commissioner Garcia asked if there was any internal training for cultural encounters and what does the training entail? She then asked what is our racial breakdown (Hispanic, Arabic, etc.), and how well to they perform? She also said that It appears that the bilingual employees don't last. Commissioner Blackmon added that maybe there is a need for an in-house review. Is there any attempt to find out why employees are leaving and is there something the Department can to do to retain them.

Commissioner Davis suggested a presentation at the April customer service meeting on Cultural Training.

Commissioner Forte said it sounds like two matters to address: 1). Cultural Training and 2). Retention.

Director Brown added that human resources should pay special attention to exit interviews. He also said that employees have the ability to report issues that they have anonymously, and that the Department is required to address how they handled the concerns and to report to the Board.
