1. CALL TO ORDER

Chairperson Einheuser called the meeting to order at 2:00 p.m.

2. ROLL CALL

3. APPROVAL OF AGENDA

Chairperson Einheuser requested approval of the agenda.

A motion was made by Vice Chairperson Mary Blackmon, seconded by Commissioner John Henry Davis that the agenda be approved. The motion carried by a unanimous vote.

4. APPROVAL OF MINUTES

Chairperson Einheuser requested approval of the minutes of June 21, 2023.

A motion was made by Commissioner John Henry Davis, seconded by Commissioner Linda Forte that the minutes be approved. The motion carried by a unanimous vote.

5. PUBLIC COMMENTS (3 minutes per speaker)

a. Cecily McClellan with We the People of Detroit came before the Board about a customer who had a leak in her home. She requested the leak policy, but was denied due to delinquency on her current bill. Ms. McClellan said there should be

consideration or waiver to those applying for the leak adjustment if they can prove that the plumbing issue was repaired, and that was the source of the large bill. Ms. McClellan asked whether DWSD provides any oversight of Wayne Metro's records to ensure that eligible clients/residents of Detroit are receiving the services being provided.

b. Demeeko Williams, Chief Executive Director of Hydrate Detroit thanked the BOWC, customer service, and the executive staff for the continued partnership with Hydrate Detroit in serving the citizens of Detroit. He also mentioned that the Shared Water Drive was scheduled for Saturday, July 22, 2023 at the Avalon Village Center in Highland Park.

c. Norrel Hemphill with Great Lakes Environmental Law Center stated that the Lifeline Plan is a great step in the right direction. She looks forward to a sustainable funding source. She also paid homage to the late Honorable JoAnn Watson, former Detroit City Council Member.

d. Gwendolyn Howard with We the People of Detroit said that the Lifeline Plan is a great start but it is not a permanent source.

e. Derrick Spears came before the Board about a damage claim due to a water main break.

f. Akil Clark came before the Board regarding on-going basement flooding.

6. COMMUNICATIONS

A. <u>2023-162</u> The Board of Water Commissioners for the City of Detroit, Water and Sewerage Department approval to **adopt the Legal and Government Affairs Committee Charter**, and also authorizes the Director to take such other action as may be necessary to accomplish the intent of this vote.

7. ITEMS FROM THE COMMISSIONERS

Vice Chairperson Blackmon commended Matthew Phillips, Chief Customer Service Officer for assisting an elderly citizen with his water bill. She also acknowledged JoAnn Watson, former Detroit City Council Member, for her lifetime of community advocacy and social justice work.

Commissioner Kinloch requested a copy of the work group material being drafted to legislation regarding permanent funding for water affordability.

8. UNFINISHED BUSINESS

There was none.

9. APPROVAL OF CONSENT AGENDA (Items 9A-F)

2023-151 The Board of Water Commissioners for the City of Detroit, Water and Sewerage Α. 6005362 Department authorizes the Director to approve **DWSD** Contract (DWS-964) with Pipetek Infrastructure Services Sewer Condition for Assessment Services in Hubbard Farms, along Michigan Avenue, Midtown, and North Corktown, for a term of 2 years and a total contract amount not-to-exceed \$5,579,680.14. This also authorizes the Director to take such other action as may be necessary to accomplish the intent of this vote.

This also authorizes the Director to take such other action as may be necessary to accomplish the intent of this vote.

C. 2023-153 The Board of Water Commissioners for the City of Detroit, Water and Sewerage Department authorizes the Director to approve Amendment 1 for DWSD Contract No. 6004872 with Etna Supply Company LLC for repair clamps of various sizes, by adding \$75,000.00 in funding for a total amended contract not-to-exceed amount of \$291,441.75. No change in time, scope of work or contract terms and conditions. The BOWC also authorizes the Director to take such other action as may be necessary to accomplish the intent of this vote.

D. 2023-154 The Board of Water Commissioners for the City of Detroit, Water and Sewerage Department authorizes the Director to approve DWSD Contract 6005483 with WCI Contractors, Inc. for As-Needed Lawn Repairs and Restoration Services throughout various locations within the City of Detroit, for a total **contract amount not-to-exceed \$4,289,200 and a term of three years.** This also authorizes the Director to take such other action as may be necessary to accomplish the intent of this vote.

2023-167 The Board of Water Commissioners for the City of Detroit, Water and Sewerage Ε. DWSD 6005502 Department authorizes the Director to approve Contract (WS-732) with Murphy Pipeline Contractors, LLC. for Water Main Replacement and Water Service Replacement including Lead Service Line for various locations, west of Livernois Avenue within the City replacement, of Detroit, total contract not-to-exceed amount of \$12,791,611.00 for a (reimbursable by ARPA funding) and a term of two years. This also authorizes the Director to take such other action as may be necessary to accomplish the intent of this vote.

Director Brown replied that Tiffany Jones, Diversity and Inclusion Director, spearheads the DWSD initiative to ensure that minority representation is included in future contracting on water related projects. Commissioner Kinloch requested that the minority Detroit Based Business (DBB) is a workshop agenda item at the retreat.
