B. 20-0196 The Board of Water Commissioners for the City of Detroit, Water and Sewerage

Department authorizes the Director to approve Purchase Order No. 3044431 to Secure Door, LLC for the replacement and installation of ten (10) overhead doors at two DWSD facilities for a total amount not-to-exceed \$351,204.
