BACKGROUND AND JUSTIFICATION

DWSD Human Resources has submitted for your approval the Collective Bargaining Agreement (CBA) with AFSCME-Local 2920 (hereinafter "the Union") having a term ending June 30, 2021. This CBA reflects the Agreement reached between DWSD and the AFSCME-Local 2920 bargaining team. The Union ratified the aforementioned CBA on Tuesday February 27, 2018. As such, we respectfully request that your Honorable Body approve the CBA this day, Wednesday, March 7, 2018.
