issued Executive Order No. 2020-15 allowing remote participation in public meetings and hearings for public bodies subject to the Open Meetings Act.

The public body also may use technology to facilitate typed public comments that may be read to or shared with members of the public body and other participants.

Any member of the public may dial in to listen to the meeting. Board Members will also participate by phone. Meeting materials will be posted on dwsd.legistar.com
