BACKGROUND

The Detroit Water and Sewerage Department (DWSD) entered into a contract with Miller, Canfield, Paddock & Stone, P.L.C. to provide legal representation, consultation and advice to DWSD in connection with pending litigation with the United House of Prayer V City of Detroit, Wayne County Circuit Court Case No. 15-009083-CZ.

The Director of the Detroit Water and Sewerage Department approved the award of the initial contract, which was procured through an exception from competition, with Miller, Canfield, Paddock & Stone, P.L.C. on October 14, 2015 with a total contract amount not-to-exceed of \$100,000. Amendment No. 1 added \$150,000 for a new total contract amount of \$250,000 was approved by the DWSD Director in July 2018.

JUSTIFICATION

Based on the information above, the DWSD General Counsel Division is requesting an additional \$50,000 in funding, for a total amended contract amount of \$300,000 for continued legal services relating to the litigation with the United House of Prayer V City of Detroit, Wayne County Circuit Court Case No. 15-009083-CZ.
